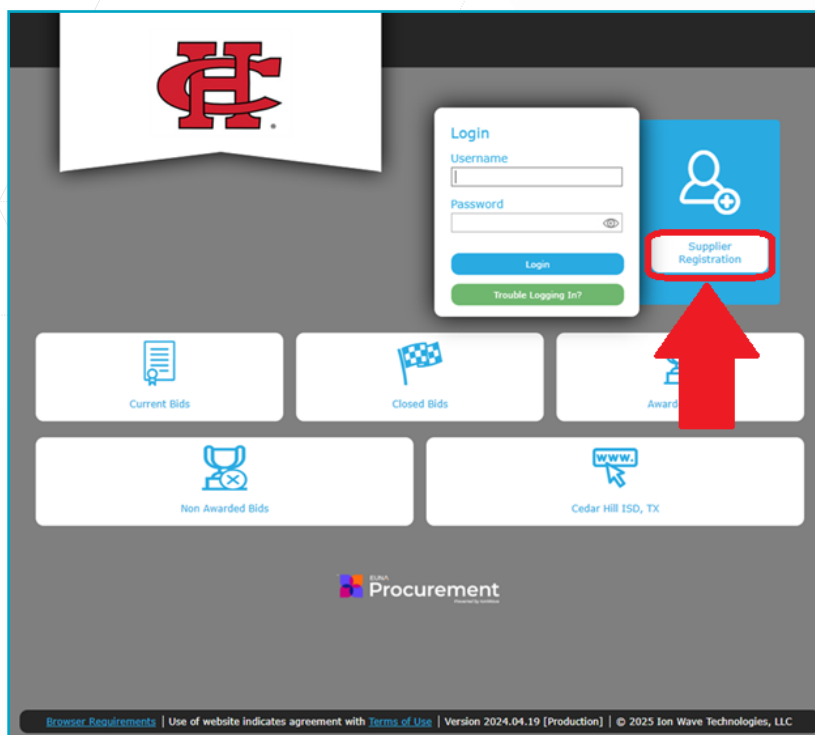
How to Register and Submit a Bid on the CHISD IonWave Portal

Overview: Cedar Hill ISD (CHISD) posts bids (including property sales) on its IonWave purchasing portal. To submit a bid, you must first register as a vendor on the portal. Then you can log in, find the CHISD property sale event, download and complete the bid forms, and upload your response. The steps below walk you through this process.

Register on the IonWave Portal

First, go to the Cedar Hill ISD IonWave bidding website at chisdbids.ionwave.net. The CHISD Purchasing Department notes that to do business with the district you must first register at this portal.

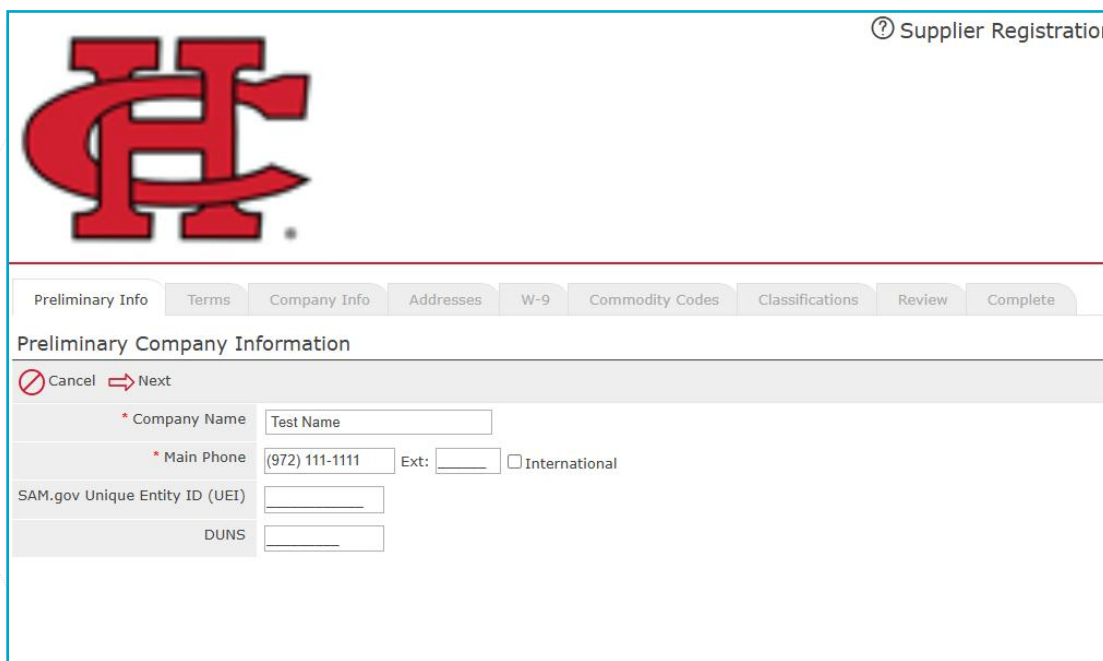
Step 1: Click **Supplier Registration** on the portal login page.



Registration in IonWave is free; no payment or subscription is required!

When you have completed all sections, click **Complete** to submit your registration. You should receive a confirmation email when your account is created.

Step 2: Fill out the Preliminary Info page (company name, contact person, phone, etc.) and click Next.

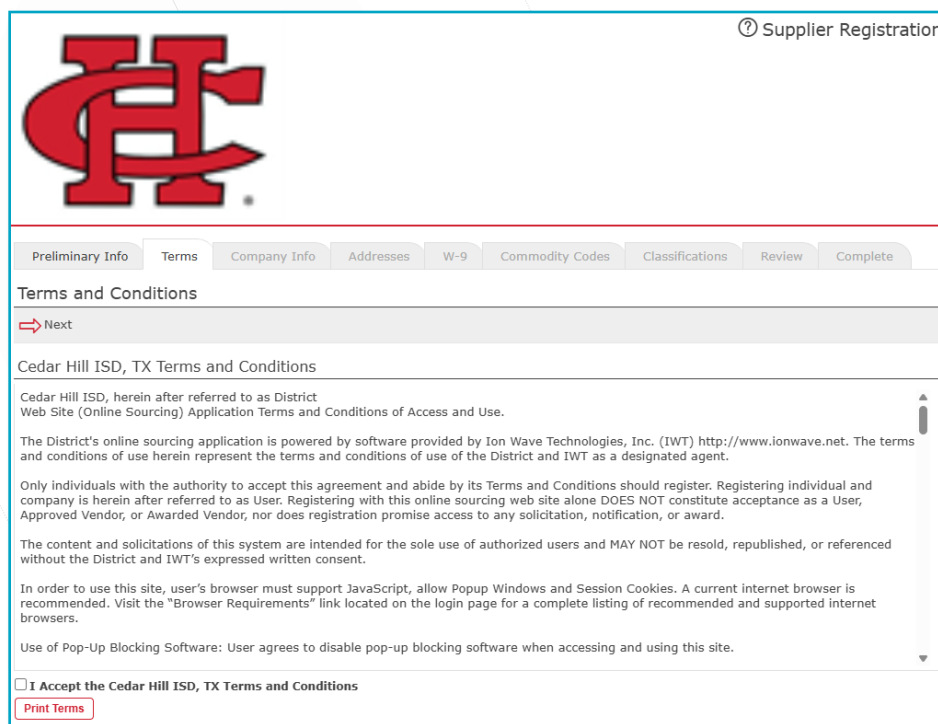

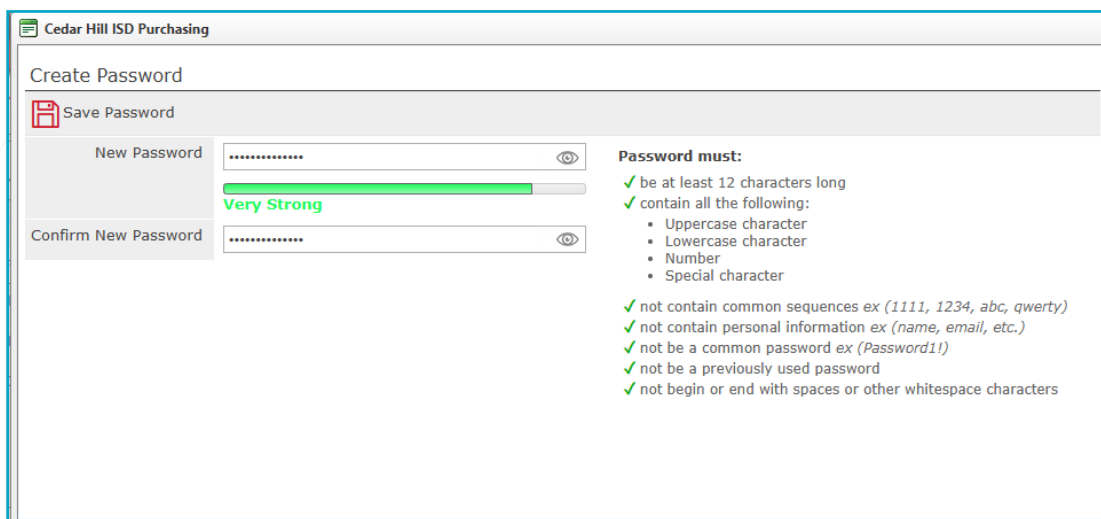

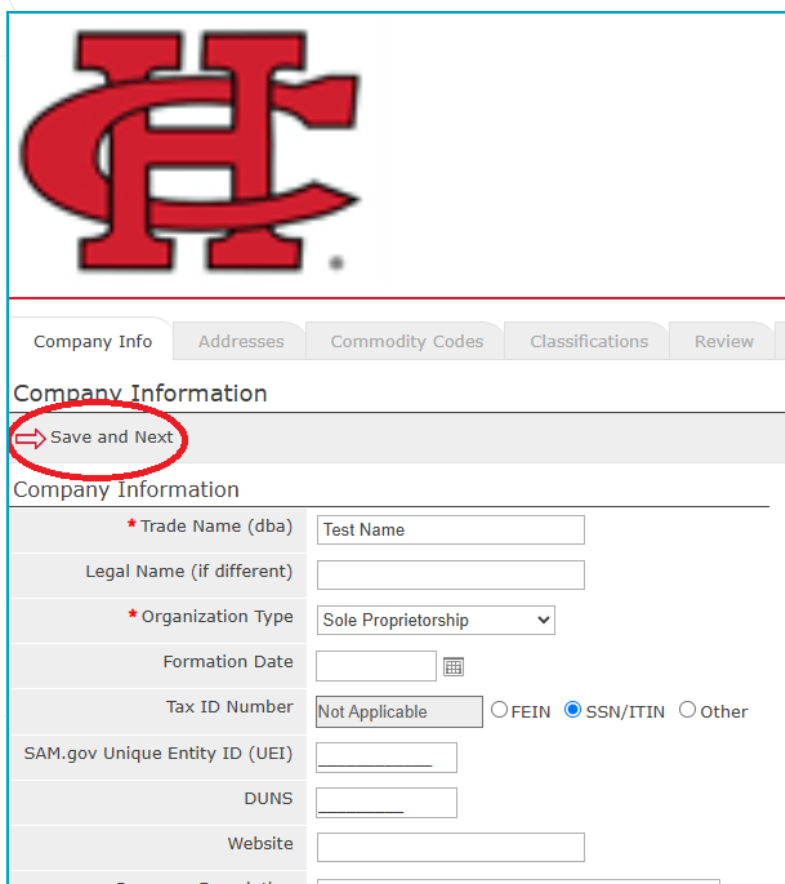

 - Uppercase character
 - Lowercase character
 - Number
 - Special character
- ✓ not contain common sequences ex (1111, 1234, abc, qwerty)
- ✓ not contain personal information ex (name, email, etc.)
- ✓ not be a common password ex (Password1!)
- ✓ not be a previously used password
- ✓ not begin or end with spaces or other whitespace characters

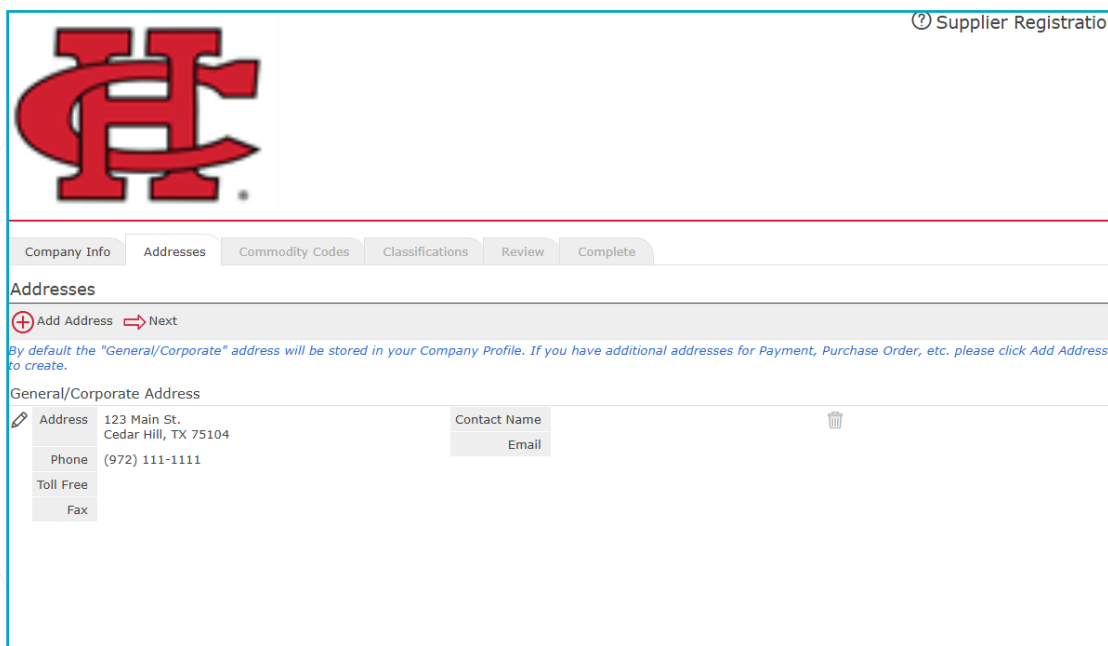

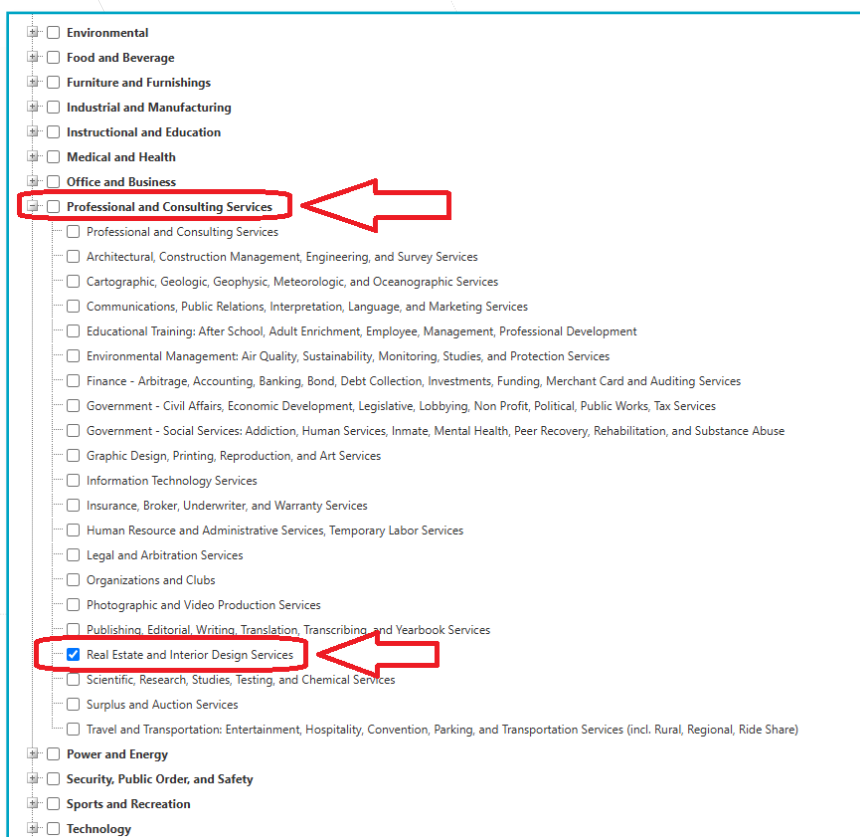

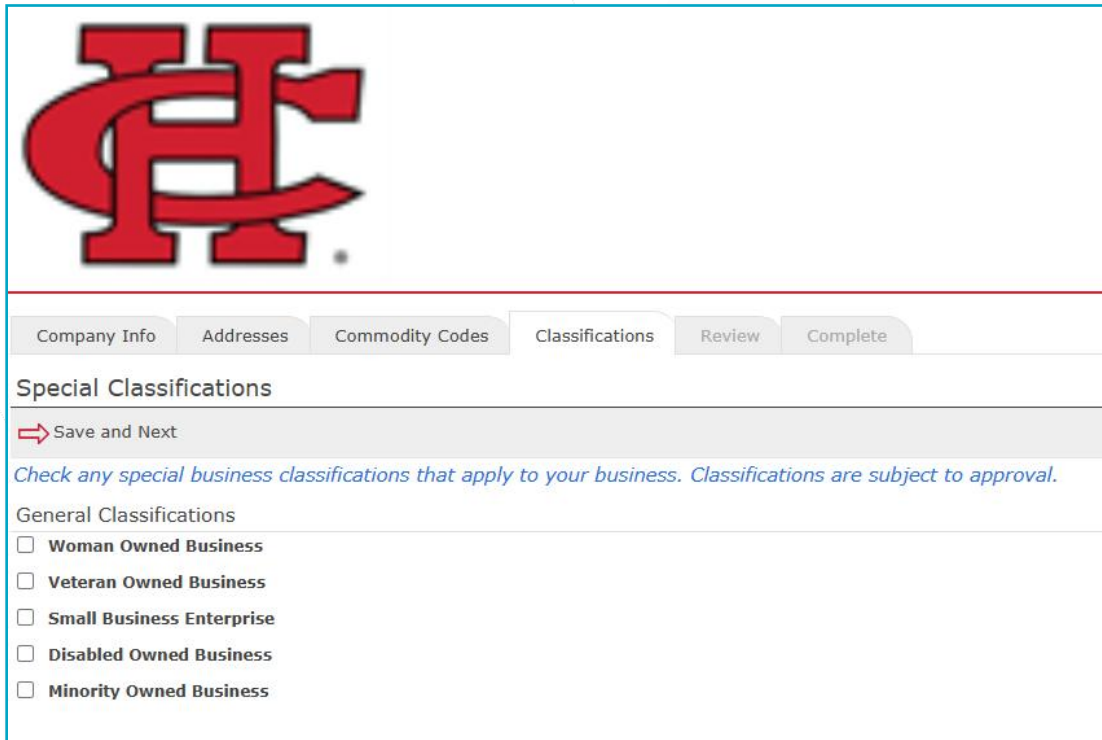

Step 9: If you are bidding as a company and match one of the following statuses, select the appropriate status and attach the supporting document. Otherwise, you can just click the **Save and Next** button.

Step 10: Review and Submit the registration. After submission you will see confirmation and will be able to log in.

Access the CHISD Property Sale Event

After registering, log in to the portal with your new username and password. You will see a menu with options like **Current Bids**. Click **Current Bids** (or “Current Bid Opportunities”) to view all open solicitations. In the list of current bids, locate the entry for the CHISD property sale event (**RFP 24/25-016**). Click the **Bid Title** or **Bid Number** of that event to open the bid details. On the event page, you can review the bid summary and any announcements.

Submitting Your Bid

Within the property sale event page, go to the **Attachments** tab. Here you will see a list of required documents (for example, bid forms, disclosure statements, etc.). **Download** each file and fill it out carefully.

After you have completed the forms offline, switch to the **Response Attachments** tab on the same portal page. Click **Upload** to attach your completed documents. Upload each file (typically PDF) as instructed. Make sure to include any required bid forms or signature pages. Fill in any required text fields on the form, then **Save** your entries. Finally, click **Submit Response** (or **Submit**) to send your bid through the portal.

- **IMPORTANT:** CHISD does *not* accept bids sent by fax or email. All bids **must** be submitted electronically through IonWave.
- **Deadline:** Your bid must be fully submitted by **the specific property deadline as listed on the IonWave portal**. Any submission after that time will be considered late and will not be accepted.

Additional Notes

- **Free Registration:** IonWave vendor accounts are free. There is no cost to sign up and download the bid documents.
- **District Rights:** Cedar Hill ISD reserves the right to reject any or all bids and to waive any informalities or minor irregularities in the bidding process.

Each step above is designed to ensure your bid is properly recorded. By following this guide, you will successfully register on the IonWave portal, locate the CHISD property sale event, and submit your bid by the deadline. Good luck!
